#### **Credit Builder Loans**

If you need to build or rebuild your credit, you can borrow money and the loan proceeds will be placed in a share account as collateral for your loan. When you are finished, the amount you have pledged as collateral for the loan will be a nice nest egg you have saved. You build your credit as you build your savings. Just complete a loan application and tell us you are applying for the Credit Builder Loan.

### Methods To Help You Save

When you enroll in our Save the Change program, we'll round up your debit card purchases to the nearest dollar and transfer the extra change to your savings account! It's an easy way to start saving money. You can also sign up for an Automatic Savings Transfer for as much as you want and as often as you want. ### Refinance High-Interest-Rate Loans

### Can Home\$tart Provide A Down Payment For You?

If a down payment is preventing you from owning a home, we may be able to help! Because HRCU is a member of the Federal Home Loan Bank of Des Moines, we can offer a \$7,500 down payment grant to those that meet the income limits and credit requirements, are a first-time home owner, have a sales contract, complete an accepted homebuyer education class and close their mortgage loan with us.\*

\*Offer availability dependent on grant funds availability. Grant may be used towards a down payment and/or closing costs. First-time home buyer is an individual or an individual and her/his spouse who have not owned a home during the prior 3-year period unless they are a displaced homemaker or a single parent. The purchase of the home with down payment assistance requires that the grant recipient live in the home for five years. If the grant recipient lives in the house less than five years, the purchaser will be obligated to return a portion of the grant based on the length of time the grant recipient owned the home.



# Your Home Can Help You!

Needing emergency cash due to the COVID-19 pandemic? Believe it or not, the home you own could help you. Apply at Holyrosarycu.org for a line of credit up to 100% of the equity you have in your home.\*

A home equity line of credit loan — also known as a HELOC — is a revolving line of credit, much like a credit card. You can borrow up to your line of credit, any time you need it, by writing a check connected to the account. Because a HELOC is a line of credit, you make payments only on the amount you actually borrow, not the full amount available.

If you already have a HELOC with another financial institution, consider refinancing with us. You could reduce your interest rate and monthly payments so that the repayment period becomes more affordable. Your home's value also may have increased since you took out your HELOC. If this is the case, a HELOC refinance can allow you to get more money from your home equity!
