

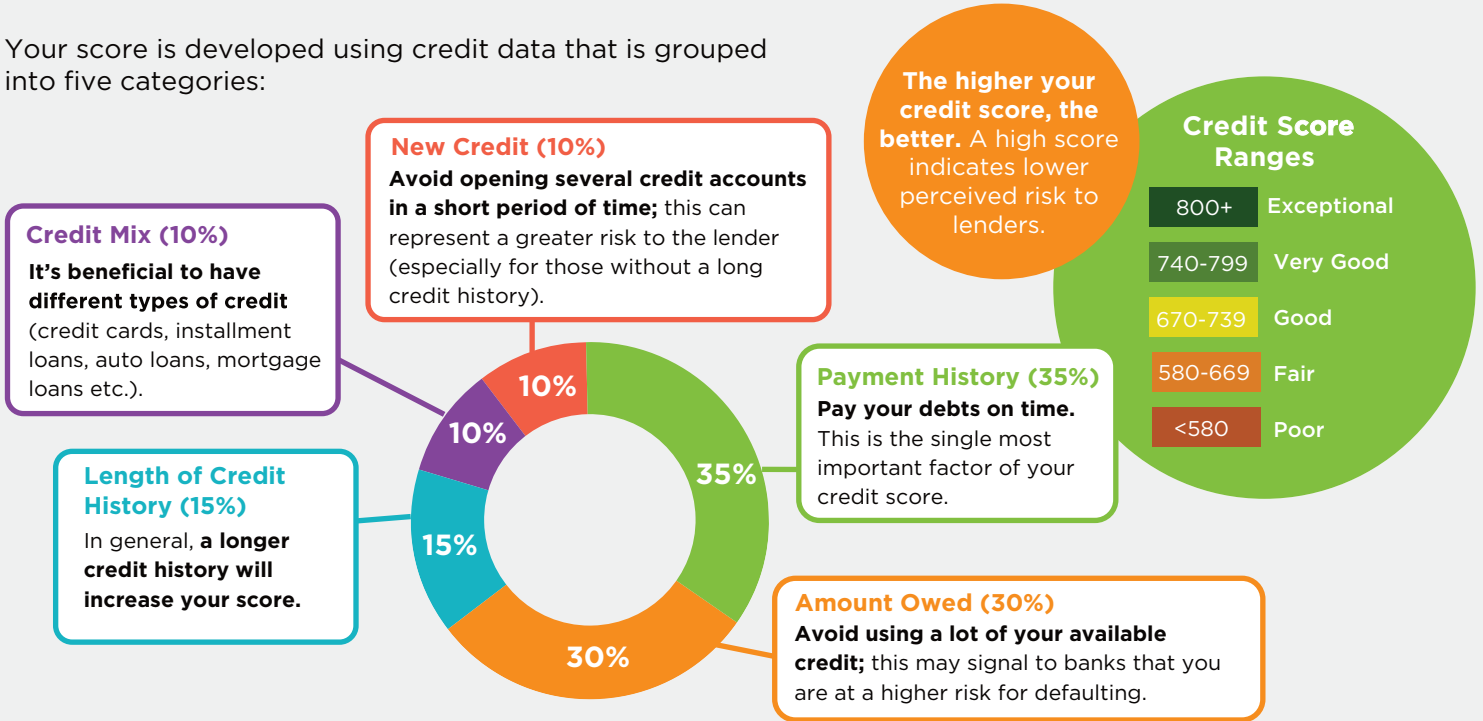


## Understanding Your Credit
